# Notice of Public Meeting Committee of Adjustment

**Application for Consent to Sever has been submitted by Phyllis Hilliard, owner of the subject lands.**

**Property Location: 64 & 68 30<sup>th</sup> Street North**

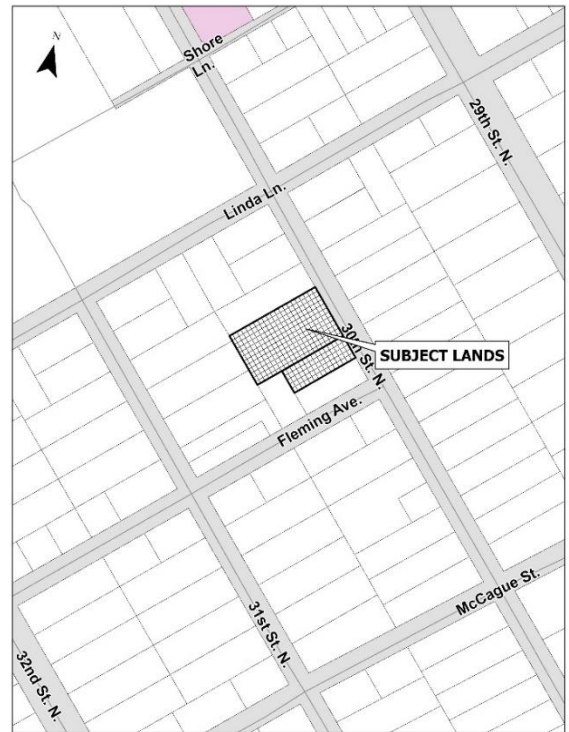

## What is being proposed?

The application proposes to create one (1) new lot, for a total of two (2) lots.

The subject lands have a total lot frontage of approximately 44.06 metres (144.55 ft.), a depth of approximately 53.44 metres (175.33 ft.) and a total lot area of approximately 2,100 square metres (22,604.21 sq. ft.).



The portion of the lands proposed to be severed, as shown on the severance sketch provided as 'Part 2' has a frontage of approximately 13.58 metres (44.55 ft.), a depth of approximately 38.22 metres (125.39 ft.) and an area of approximately 500 square metres (5,381.96 sq. ft.).

The portion of the lands proposed to be retained, as shown on the severance sketch provided as 'Part 1' has a frontage of approximately 30.48 metres (100 ft.), a depth of approximately 53.44 metres (175.33 ft.) and an area of approximately 1,600 square metres (17,222.26 sq. ft.).

**OTHER APPLICATIONS:** The property subject to this application for Consent is not currently the subject of other application(s) under the *Planning Act*.

The legal description of the subject lands is SUNNIDALE CON 16 PT LOT 4 PT;RD ALLOW AND PLAN 705 PT;LOTS K L M & CON 16 PT LOT 4.

**Why Am I Receiving This Notice?**

You are receiving this notice because the applicant noted above has submitted a Consent application to the Town of Wasaga Beach. As stipulated by the *Planning Act*, notice must be provided to property owners within 60 metres (200 ft.) of the area to which the application applies.

**A note about information you may submit to the Town:**
