#### 1. ACKNOWLEDGMENT OF INHERENT RISK

I understand that participation in Town of Wasaga Beach run Recreation Programs, or any other activity occurring on or off site of a Town run facility (hereinafter the "Program") is voluntary, and involves inherent risk during participation, including the risk of possible accidents, physical injury, or exposure to the COVID-19 virus or other infections or infectious diseases as a result of attendance. On my own behalf, I freely accept and fully assume all such risks, dangers and hazards, including but not limited to personal injury, disease transmission, death, property damage or loss, resulting from my attendance and/or participation.

#### 2. WAIVER

I do for myself, and our respective heirs, executors, administrators, successors and assigns, hereby waive, release, and forever discharge the Corporation of the Town of Wasaga Beach, their Councillors, Officers, partners, agents, employees, servants, representatives, volunteers, officials, successors and assigns (the "Representatives") of and from any actions, causes of action, complaints, demands and claims or any recourse whatsoever ("Claims") that I have or may have in the future in any way connected with my participation in the Program contemplated herein, whether in law or in equity, in respect of personal injury, illness or disease transmission, loss of life, or property damage of any kind or nature, and I do hereby discharge the Representatives from any such liability. This includes negligence, breach of contract or breach of any statutory or other duty of care.

#### 3. INDEMNIFICATION

I further agree to fully indemnify and defend the Representatives, including all related costs and expenses, and against any loss, costs, damages, or expenses which the Representatives may sustain, suffer, incur, or be liable for resulting from, arising from, or in any way related to my participation in the Program. I also agree and undertake not to make any claim or take any proceedings against the Representatives set out above, or any other person or corporation which might claim contribution or indemnity under the provisions of any statute or otherwise from the Representatives set out above.

#### 4. SEVERABILITY

The provisions of this Assumption of Risk and Waiver shall be deemed severable and if any provision or portion thereof is held invalid, illegal or unenforceable for any reason, the remainder shall not thereby be invalidated, but shall remain in full force and effect.

#### 5. MEDIA RELEASE

I hereby grant to the Town of Wasaga Beach the right to reproduce, use, exhibit, display, broadcast, distribute and create derivative works of the photographed images of me or my child, taken during the course of the Program, for use in connection with the activities of the Town of Wasaga Beach for promoting, publicizing or explaining the Town or its activities. This includes, without limitation, the right to publish such images on the Town Web Page, Social Media Platform or in printed materials.
