Enclosed is your water bill for the months of March and April. If your water bill indicates a balance forward, it's important to note that interest has been calculated to the current billing date. Interest will be applied at 1.25% on the first day of each month thereafter. For your convenience, your water bill can be paid in the comfort of your home through online banking.

Please contact the Water Clerk at (705) 429-3844 ext. 2245 if you experience any of the following:

- If the property was <u>occupied</u> during this billing cycle but both the **Previous and Current Read are the same.**
- If the current bill reflects 'Flat Rate Residential' water/sewer rates.



Now when you visit Town Hall to make a payment you can receive your receipt via email. Ask a Customer Service Representative for further details.

The town is also offering paperless water and tax bills.

Sign up for e-billing and receive your bills via e-mail. If you would like to sign up for this option please e-mail ebilling@ wasagabeach.com and include the following:

- **1** The subject line should state the municipal property address, starting with the street name. For example, Main Street 123.
- **2** The body of the e-mail should state your name and phone number.
- **3** The e-mail must come from the e-mail address you want the bill sent to.

Message from the Mayor

This is an exciting time to be a resident of Wasaga Beach.

In early April, Gateway Casinos and Entertainment Ltd. announced its Wasaga Beach casino will be built on property south of the Beachwood Road roundabout.

The best part of this announcement is the creation of roughly 150 new jobs. For a small town like ours, this is a tremendous jolt for local employment.

On top of this, the town will receive a dependable revenue stream from the casino. The amount will be anywhere from \$1.5-million to \$2-million annually.

For our community this is good news.

I am also happy to tell you that at the end of March your council approved the town's 2019 budget. (See related item in this newsletter).

We are investing almost \$24-million in capital projects this year. This includes funding for bridges, roads, water and sewer, parks and recreation, and more.

Two projects I will highlight are the library and the arena. We have set aside funds for the design work of both structures.

On a related note, we have shortlisted sites for a new library and arena.

For the library, we now have a list of seven potential sites.

For the arena, we have a list of six sites.

We hope to share more about these two projects soon. Your council is committed to building these facilities during this term of council.

Council and town staff are also busy determining how best to proceed with development of our beachfront lands.

Council has directed staff to look at options to divest the property. This includes creating parcels that are large enough to support large-scale development rather than a piecemeal approach. We will provide additional updates to you as we go forward. Ultimately, we want to revitalize this integral part of our community.



Council is supportive of a Festival Square on these lands, as it will create a gathering spot for us all.

As well, a vibrant and successful beachfront is key to developing our economic competitiveness.

We are going to achieve all of this in an equitable, fair, and transparent fashion.

Wherever I travel in Wasaga Beach, I get a real sense of optimism from the people who speak with me.

I can tell you that this council is placing the needs of our residents first by prioritizing services and community assets that affect the people living here.

Our focus as your representatives is simple: Serve our residents, support our community, build our economy, and lead for tomorrow.

By working together, we are moving Wasaga Beach forward.

Water conservation rebates are available

The Town of Wasaga Beach has a water conservation rebate program.

When you install a low flow or dual flush toilet you are eligible for a \$70 rebate. Residents who install a rain barrel can get a \$30 rebate.

Open Fires By-law

The Town of Wasaga Beach would like to remind its residents and visitors of the "open fires" by-law.

Property owners are not required to obtain a permit, however, the by-law rules must be followed to ensure fire and health safety.

- Only dry seasoned firewood shall be burned (no rubbish or yard waste).
- Smoke from the fire is your responsibility; do not allow smoke to interfere with others enjoyment of their property.
- A fire shall only be set in an outdoor burning device complete with a spark

Town council approves 2019 budget

Council approved the 2019 budget on March 26.

For 2019, the tax rate increase is 2.91 percent on the municipal portion of the tax bill. The impact of the increase on the average assessed home in Wasaga Beach is \$51.92.

The total operating and capital budgets is \$64 million, an increase of \$9 million when compared to the 2018 budget.

The budget for operating expenditures is \$40.1 million. The operating budget

- Fire shall be less than 1 metre in diameter and ½ metre in height.
- A minimum of 4 metres from any combustible material must be maintained (i.e. structures, fence, trees etc.).
- Each fire shall be supervised by a responsible adult with access to adequate means of extinguishment (i.e. garden hose, bucket of water etc.).

earmarks funds for the hiring of additional staff in strategic areas across multiple departments to improve the level of service provided to our residents.

Funds are also set aside to work with developers in building projects in our community that meet council's priorities of providing more affordable housing and diversifying the tax base.

The budget for capital expenditures is \$23.8 million, with the largest portion of this going towards roads and bridges (\$10.6 million).
